



Psychotherapist/Professional Counselor

Psychotherapist/professional counselor will provide outpatient individual and family therapy to patients of Vida Counseling, located in the Midtown area of Raleigh. Clinical therapy services include treatment of children, adults, family and couples. Treatment specialties may include: play therapy, somatic experiencing/sensorimotor psychotherapy, eating disorders, couples, trauma, EMDR, family, etc.

Vida Counseling is currently seeking a clinician that specializes in therapy services for children and families.

Minimum Qualification Requirements:

- Master's Degree or Doctoral Degree in counseling or social work **from a CACREP accredited program;**
- Licensed or provisionally licensed (LPCA, LPC, LCSW, LMFT) as a clinician in the state of North Carolina. License verification must be provided to Vida Counseling. **Bilingual Preferred.**
- Position requires a minimum caseload of 20 clients/3 days per week, provided such sessions are available and referred/scheduled by Vida Counseling.

Other Qualification Preferences:

- Spanish or Portuguese speaking is strongly preferred.
- Fluent in any other second language.
- Have at least one niche market for counseling services (i.e., somatic therapy, play therapy, teens, trauma, anxiety, grief, anger management, etc.).

Hours:

Work hours and schedule may vary depending on patient and Vida Counseling needs. Hours include nights and weekends. Therapist is not guaranteed a minimum number of clients or sessions per week. However, it is expected that therapists will be available to hold a minimum caseload of 20 clients/3 days per week, provided such sessions are available and referred/scheduled by Vida Counseling. Patient sessions are held at the Vida Counseling Office.

Preferably, clinician will be available Monday afternoons 4-7 PM, Tuesday, Wednesday, and Saturdays.



Job Duties and Responsibilities:

1. Perform on-site clinical counseling services to clients of Vida Counseling, as scheduled, and in accordance with company policies.
2. Regular and reliable attendance and timely arrival to work is required.
3. Be properly licensed and abide by all laws, rules, regulations, and codes of ethics that are binding upon or applicable to the services performed for Vida Counseling.
4. Respond to patients' requests for service or calls within 24 hours whether such requests are made in person, by phone, voicemail, etc. or through the Vida Counseling website. Respond to such requests by meeting, evaluating, and providing services to such clients.
5. Communicate with a client's treatment team (i.e., PCP, psychiatrist, school, etc.) as necessary.
6. Timely complete written records for each patient including, but not limited to: intake notes, progress notes, treatment plans, termination notes, contract notes, and other forms or documents which may be needed or required from time-to-time by Vida Counseling or third parties in conjunction with the treatment of the patient within a timely fashion (by Friday of each week). Keep patient files accurate and up to date.
7. Charge and collect payments from patients for services provided consistent with the policy and rate for such services as established by Vida Counseling.
8. Attend mandatory staff meetings and training as directed by Vida Counseling.
9. Conduct and regulate counseling services in a professional manner so as to maintain and increase the good will and reputation of Vida Counseling. Be respectful of and cooperative and collaborative with co-workers.
10. Other duties which may be assigned by Vida Counseling.
